

The screen is then aligned on the Tri-Loc Master Registration Frame. Three stop points assure that the screen and film are precisely and tightly locked into the desired position during vacuum pull down.



The operator simply raises the press carousel, pulls the screen into contact with the pallet's three stop points, and locks the screen into place. The result is precise and repeatable registration from print head to print head.
